# **Education Exemption Route Accepted Qualifications**



#### **Education Exemption Introduction**

An education exemption is the recognition that you have met the education requirement by virtue of a previously earned qualification which signified you already have the requisite knowledge included in the education. If you are granted an education exemption, you are not required to pass the course with an Education Provider or in the FPSB system quizzes. Instead, you may proceed to take the prequalification exam and (upon successful passing), the certification exam.

### **Education Exemption Process**

- 1. Register with FPSB Ltd.
- 2. Submit documentation in the FPSB online portal to request an education exemption.
- 3. FPSB will notify you within 14 days if your documentation is accepted as valid.
- 4. If approved, you may proceed to take the online prequalification exam in the FPSB online portal. This is a 2-hour exam with 75 multiple choice questions that, upon passing, proves your eligibility to take the in-person certification exam. You may take this exam up to two times.
- 5. If you do not pass the prequalification exam within two attempts, you are no longer eligible for the education exemption route and mut pursue the Individual-led education or Instructor-led education.
- 6. If you pass the prequalification exam within two attempts, you will be eligible to sit for the certification exam.
